GREEN BAY VS. DALLAS TICKET SWEEPSTAKES**

OFFICIAL SWEEPSTAKES RULES

- **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT IMPROVE YOUR ODDS OF WINNING.**

1. **Sponsor and Administrator:** The Green Bay vs. Dallas Ticket Sweepstakes (“Sweepstakes”) is sponsored and administered by Titledown Sportservice Inc. (“Sponsor”). Sponsor operates The Turn, which is located at 1025 Lombardi Ave, Suite 120, Green Bay, WI 54304.

2. **Submission Period and Drawing:** The Sweepstakes begins at 12:00 p.m. CST on October 24, 2022, and runs until 8:30 p.m. CST on November 9, 2022 (the “Submission Period”). Submission Period may be extended in Sponsor’s sole discretion . A random drawing will be held on November 10, 2022, by Sponsor to select the winner from among all eligible entries received. To be considered eligible entries must be submitted during the Submission Period. Odds of winning the prize depend on total number of eligible entries received during the Submission Period. Under no circumstances will Sponsor award more than one prize. Sponsor cannot accurately predict the number of entrants who will participate in the Sweepstakes (each an “Entrant”).

3. **Entrant’s Acceptance of Rules.** By participating in the Sweepstakes, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Sweepstakes Rules (the “Rules”) and the decisions of Sponsor, which shall be final and binding in all respects. This Sweepstakes is void in Puerto Rico, and all other U.S. territories, U.S. military installations in foreign countries and possessions and everywhere prohibited by law.

4. **Eligibility:** The Sweepstakes is open only to legal residents of the United States who are 18 years of age and older or if different, the age of majority as established by such individual’s state of residence, as of the date of entry. Employees, officers, directors, managers and members, along with their respective immediate family members, of Sponsor and its affiliates, and any other entities involved in any manner with the marketing, sponsoring, fulfilling or administration of the Sweepstakes (collectively, the “Sweepstakes Entities”), are not eligible to participate or win. the same residence as the winner at least three (3) months per year, whether related or not.

5. **How to Enter:** NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. There are three (3) valid modes of entry for this Sweepstakes. Limit one (1) entry per person.

(i) To enter this Sweepstakes, Entrants can fill out the form online at <https://theturngreenbay.com/ticket-giveaway/>. Normal Internet access, phone charges and usage charges imposed by your online/phone service provider(s) will apply.

You may be asked to consent to receive promotional emails or offers. This is optional and does not affect your chances of winning a prize in this Sweepstakes. You are NOT required to give consent to receive such emails or offers in order to participate in the Sweepstakes or win any prize.

Limit of one entry per person during the Entry Period. Multiple entries as determined by Sponsor in its sole discretion, will result in disqualification of all entries by such person. Entries that do not conform to or that violate these Official Rules or are submitted in any manner other than stated in these Official Rules will be disqualified. By entering this Sweepstakes, entrants agree to these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Sweepstakes.

To remain eligible, you must also maintain the like/follow until the end of the Submission Period. If you do not have an Instagram account or Facebook account, establishing an account is free. All Instagram and Facebook terms apply. Your Instagram account or Facebook account must be set to “public” in order for your entry to be eligible. You can return your account to “private” any time after the winners have been announced. Normal Internet access, phone charges and usage charges imposed by your online/phone service provider(s) will apply.

Limit one entry per person on each social media platform during the Entry Period. Entries that do not conform to or that violate these Official Rules or are submitted in any manner other than stated in these Official Rules will be disqualified. By entering this Sweepstakes, entrants agree to these Official Rules and the decisions of the Sponsor, which are binding and final in all matters relating to this Sweepstakes.

(iii) To enter this Sweepstakes, Entrants can obtain an entry form, which will be available only during the Submission Period, at The Turn, the restaurant operated by Sponsor and located at 1025 Lombardi Ave, Suite 120, Green Bay, WI 54304. Entry forms will be located at the hostess stand. To be eligible, all entry forms must be completed in full and returned to a Restaurant employee located within the Restaurant before the close of the Submission Period. Limit of one (1) entry per person. Any incomplete, illegible or forged entries will be disqualified. Any entries received by the Restaurant after the conclusion of the Submission Period at 8:30 PM CT on November 9, 2022, will also be disqualified.

All submitted entries become the property of the Sponsor and will not be acknowledged or returned. Sponsor reserves the right to reject and disqualify any entry that does not meet any of the terms and conditions of these Official Sweepstakes Rules. Decisions of the Sponsor are final and binding.

Sponsor is not responsible for, nor assumes any liability for (i) any incorrect or inaccurate entry information, or for any faulty, failed, garbled or jumbled electronic data transmissions; (ii) any unauthorized access to, or

theft, destruction or alteration of entries at any point in the operation of this Sweepstakes; (iii) any miscommunications related to this Sweepstakes; or (iv) any incorrect or inaccurate capture of information, or the failure to capture any information.

6. **Winner Selection:** The Sweepstakes will have one winner. The winner will be contacted via the phone number or email address provided, or if the winner entered via social media, the winner will be contact via direct message on the platform of their submission. The winner must respond within 72 hours of Sponsor's first attempt to contact winner (the "Initial Notification"). After responding to the Initial Notification, the potential winner will be required to execute and return an Affidavit of Eligibility/Release/Indemnification and a Publicity Release, where allowed by law, within five (5) business days after it is received. A potential winner who does not respond to the Initial Notification, does not meet the stated eligibility requirements, does not return the required documentation, refuses to accept the prize, or any prize notification which is returned as undeliverable will be disqualified and Sponsor will award the prize to an alternate winner selected from the remaining pool of eligible entries. A selected potential winner will not be an official winner until all required documentation has been returned, and eligibility has been formally verified. system malfunction, tampering, unauthorized intervention, fraud, technical failures, fire, flood, storm or other natural cataclysm, riot, strike, civil commotion, governmental regulation or any other causes beyond the control of Sponsor which, in its sole opinion, corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right at its sole discretion to cancel, terminate, modify or suspend the Sweepstakes and conduct the Sweepstakes selecting the prize winner from among all eligible entries received prior to the action taken by Sponsor or otherwise in a manner which is fair, equitable and in accordance with these Rules, as determined by Sponsor in its sole discretion. Inclusion in such drawing shall be each Entrant's sole and exclusive remedy under such circumstances. 9. **Prize Details and Restrictions:** The winner will receive as a prize: Two (2) tickets to the Green Bay Packers vs. Dallas Cowboys game on November 13, 2022. The prize must be redeemed by November 13, 2022. If the winner does not redeem the prize during such period, the winner forfeits the prize in its entirety.

The retail value of the prize is approximately \$312. The final retail value of the prize may be lower than the approximate retail value. If the final retail value of the prize is less than the approximate retail value, the difference shall not be awarded. Federal, state and local taxes and other governmental charges (as applicable), and the reporting consequences thereof, are the sole responsibility of winner. Winner must submit a valid executed IRS Form W9, and if required by law, will receive a 1099 tax form from Sponsor reflecting the fair market value of the prize received.
